



NOTICE TO BIDDERS

1. Notice is hereby given that the governing board ("Board") of the **Fullerton Joint Union High School District** ("District" or "Buyer") will receive sealed bids for the following contract, Bid No. 1617-17 ("Contract"):

Locker Room Heater Equipment

2. Sealed Bids will be received until 2:00 p.m. Thursday, May 4, 2017, at the District Office, located at 1051 W. Bastanchury Rd., Fullerton, California, at or after which time the bids will be opened and publicly read aloud. Any claim by a bidder of error in its bid must be made in compliance with section 5100 et seq. of the Public Contract Code. Any bid that is submitted after this time shall be non-responsive and returned to the bidder. Facsimile or e-mail bids will not be accepted.
3. The Contract consists of: **the purchase of locker room heaters (SEE ATTACHMENT "A")**. The intent of this bid is to purchase locker room heater equipment in staggered deliveries, with the pricing in place for no longer than one (1) year.
4. All bids shall be on the form provided by the District. Each bid must conform and be responsive to all pertinent Contract Documents, including, but not limited to, the Instructions to Bidders.
5. A voluntary pre-bid conference will be held on 10:00 a.m., Tuesday, April 18, 2017, at the District Office, located at 1051 W. Bastanchury Rd., Fullerton, California. All participants are required to sign in at the Board Room.

The Project Documents are on file at the following location: **C2 Reprographics**. The Project Documents include the specifications pursuant to which the Project and upon which the bidders are to base their bids.

6. The District's Board reserves the right to reject any and all bids and/or waive any irregularity in any bid received. If the District awards the Contract, the security of unsuccessful bidder(s) shall be returned within sixty (60) days from the time the award is made. Unless otherwise required by law, no bidder may withdraw its bid for ninety (90) days after the date of the bid opening.

7. The District shall award the Contract, if it awards it at all, to the lowest responsive responsible bidder based on: the base bid amount only.
