PROM TICKETS ARE NONREFUNDABLE AND NONTRANSFERABLE

Dear Parents and Students:

This year's Junior/Senior Prom will be held at the Harborside Grand Ballroom in Newport Beach, CA from 7:30 p.m. until 11:00 p.m. It is important that each prom attendee review the appropriate behavior expectations for all school and school-related functions. This contract must be signed on the reverse side by the student, parent/guardian, and Ms. Mountjoy, APSA **before the student may purchase tickets for the prom.**

Please read the following and sign the contract:

In order to attend the Fullerton Union High School prom, **all students MUST have a current FUHS student ID/and guests must present a current Picture ID,** and agree to the following:

1. I agree to a drug-free and sober prom. I will not possess or use tobacco, alcohol, drugs or any other controlled substances prior to, during, or returning from the prom.
2. I will obey all requests made by administration, teachers, chaperones, facility employees, and security personnel.
3. I will avoid displays of overly affectionate behavior and I will not dance inappropriately (which includes but is not limited to):
 - No bending over or squatting down on the floor
 - No lap dancing
 - No back to front, front to front grinding (Make sure there is space between people)
 - No moshing or slam dancing
4. FUHS Student and Guest must arrive and leave together
5. Students MUST be picked up on time (no later than 11:15 pm).
6. No admittance to the dance will be permitted after 9:00 p.m.
7. Once FUHS Student/Guest leave, they are not permitted to re-enter the dance.
8. No loitering in the parking lot of the venue.
9. **My off campus guest, if any, is under the age of 21.**
10. **I understand that if I violate any school rules between the time I purchase my ticket and the day of the dance, I WILL lose the privilege of attending the dance without reimbursement.**
11. **I understand that if I break this contract, the following consequences WILL apply:**
 - I will be sent home from the prom without reimbursement.
 - I will be suspended from school for up to five days and could face further progressive discipline.
 - I will lose ALL remaining Senior Activities and I will be excluded for a period of time from attending or participating in school activities, sports, clubs, dances and even graduation.

To help ensure the safety of all attendees and to protect the facility of any vandalism, Just My Prom will provide a licensed & bonded security company to do the light pat downs for male students & purse checks for female students prior to entering the facility.


I also agree to the following Formal Dance Security Policy provided by Just My Prom:

PLEASE READ CAREFULLY!

- THIS PROM CONTRACT MUST BE TURNED IN TO ROOM 65 FOR APPROVAL NO LATER THAN FRIDAY, MARCH 8, 2019. CONTRACTS SUBMITTED AFTER MARCH 8, 2019 WILL NOT BE ACCEPTED.
- STUDENTS WILL NEED TO PICK UP THEIR APPROVED CONTRACTS FROM ROOM 65 PRIOR TO PURCHASING A PROM TICKET.
- IF YOUR NAME IS NOT ON THE COMPUTER GENERATED LIST, YOU WILL NOT BE ADMITTED TO THE DANCE! PROM TICKETS ARE NOT SOLD AT THE DOOR.
- STUDENTS MUST BE IN ATTENDANCE FOR THE FULL DAY ON FRIDAY, APRIL 5, 2019 TO BE ADMITTED TO THE DANCE.
- PROM TICKETS ARE NON-REFUNDABLE AND NON-TRANSFERABLE

Students and Guests must show current FUHS Student ID/Picture ID to enter the dance

Due to the growing concerns expressed by parents, chaperones, club and class advisers, and administrators regarding appropriate dress standards, student behavior, and dancing styles, the following regulations have been implemented and will be enforced at all events. Although off campus, all school rules still apply.

Dress Code

- All students and guests will comply with the school dress code as it is established in the student handbook.
- Students must wear appropriate and tasteful clothing.
- Please avoid the following: Extremely short dresses, tops that expose too much cleavage, clothing that allows underwear to be exposed, tube tops, bathing suits, bare midriff, backs of dresses that fall below the waist, (not the hip bone).
