PROM TICKETS ARE NONREFUNDABLE AND NONTRANSFERABLE

To ensure that everyone has a memorable evening, each prom attendee (this includes any guest) must review the appropriate behavior expectations for all school and school-related functions as outlined in the Fullerton High School handbook, as well as review and agree to the following:

1. You may not attend if suspended the week of the dance. You must be in attendance for all of your classes on the day before the dance.
2. All students must check in by **9:00 PM** and will not be permitted to leave the venue until **10:30 PM**.
3. You and your guest must observe the school dress code.
 - a. Attire that is too revealing, low cut, or excessively sheer is inappropriate for any school activity.
 - b. Please check with an administrator if you have any doubts about your attire.
4. Any student who is not a current Fullerton HS junior or senior will pay the guest price.
5. Students MUST have a school ID to purchase a ticket AND enter the dance.
 - a. If you do not have an ID card, a duplicate card may be purchased for \$8.
 - b. Admission is done through PICTURE ID and a list of tickets purchased, NOT the physical ticket.
 - c. **NO PICTURE I.D. = NO ADMISSION!**
6. Parents and students should understand that there are **NO REFUNDS**.
7. Guests who are NOT Fullerton High School students must:
 - a. Be no older than the age of 20
 - b. No middle school students
 - c. Present valid picture identification (original Photo ID, Driver's License, State ID, or Military ID)
 - c. Complete a Guest Pass and receive approval from an administrator **before** the purchase of their ticket
8. Admittance of dance guests will only be granted if they are in the company of their host student.
9. No dance attendees are permitted to:
 - a. Use, be in possession, or under the influence of any type of controlled substance before, during, or after the dance
 - b. Be in possession of any type of weapon, including any look-alike weapon
 - c. Use any tobacco product, in compliance with State Law and District Policy
 - d. Bring any drinks, food, chapstick, lip gloss, gum, make-up, perfume, hairspray, dry shampoo, etc into the facility

(Any violation listed above could result in being denied entry into Prom, suspension from school, and/or loss of Senior Activities.)
10. All individuals attending the event will be subject to search and pat down by the event security staff. All vehicles are subject to search.
11. FUHS students are responsible for the conduct of their guests at all times.
 - a. Students may be subject to disciplinary action based on the conduct of their guests.
12. Hostile or aggressive behavior may result in your removal from the event and possible disciplinary action upon your return to school.
13. Dancing or behaving inappropriately may result in your removal from the event.
 - a. This includes any sexually explicit or violence-oriented dancing commonly known as freaking, moshing, grinding, etc.
14. If you decide to leave the dance for any reason, **you will not be readmitted.**
15. It is your responsibility to arrange a ride to and from the event.
16. ALL Saturday Schools MUST be cleared before purchasing a ticket/attending the dance.
17. **I understand that if I break this contract, the following consequences may apply:**

- I may be sent home from the prom without reimbursement.
- I may be suspended from school for up to five days and could face expulsion from the District.
- I may be excluded from attending or participating in school activities, sports, clubs, dances, and even graduation.

Failure to be picked up from the dance within 30 minutes of its conclusion may cause suspension from the next school dance (or loss of Senior Event Privileges). Make sure that you have a ride waiting for you after the dance!

We have read and understand the above rules and accept all responsibility for any actions taken while attending this dance. Any violation of school rules or Ed Code may result in disciplinary action, per school policy/District or State policies, and your potential immediate removal from the event. We also understand that no refunds will be granted.

I. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE THE FULLERTON

1. **JOINT UNION HIGH SCHOOL DISTRICT**, their officers, employees, Board, and agents (hereinafter referred to as "releases") from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss, damage, any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, while the undersigned participates in the sponsored school event, sponsored, planned, and directed by the **FULLERTON JOINT UNION HIGH SCHOOL DISTRICT**;

2. **THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS** the releases and each of them from any loss, liability, damage, or cost they may incur due to the participation of the undersigned in the school event, sponsored, planned, and directed by the **FULLERTON JOINT UNION HIGH SCHOOL DISTRICT**;
