Transportation is a Privilege not a Right: I understand and acknowledge that California Code of Regulations, Title 5, Section 14103(a) states:

Pupils transported in a school bus or in a school pupil activity bus shall be under the authority of, and responsible directly to, the driver of the bus, and the driver shall be held responsible for the orderly conduct of the pupils while they are on the bus or being escorted across a street, highway or road. Continued disorderly conduct or persistent refusal to submit to the authority of the driver shall be sufficient reason for a pupil to be denied transportation. A bus driver shall not require any pupil to leave the bus in route between home and school or other destinations.

I recognize the importance of the Pupil following the driver's instructions and all established safety rules, guidelines, and regulations, and agree that Pupil is responsible for abiding by all driver instructions, and all safety rules and regulations governing school transportation.
